- HUD shifted to a 2-year funding cycle. This year's application will request funds for FY2024-2025 and FY2025-2026
- In 2025, agencies may need to resubmit renewal applications to HUD. Renewal project funding may change slightly in FY2025-2026 depending on next year's congressional budget
- Tier 1 90% ARD or \$3.4 million
- Tier 2 10% ARD or \$371 thousand
